Dear Mr. Nunziata:

At the February 2025 meeting, the Accrediting Commission of Career Schools and Colleges (“ACCSC” or “the Commission”) considered the Application for Renewal of Accreditation submitted by UEI College located in Tacoma, Washington. Upon review of the September 16, 2024 On-site Evaluation Report and the school’s response to that report, the Commission voted to grant UEI College **Renewal of Accreditation**. The Commission’s action renews the school’s accreditation for a period of five (5) years going forward from August 2023.<sup>1</sup> Congratulations on this significant achievement.

The mark of an accredited school is its commitment to continuous improvement. Accordingly, the Commission has included an ACCSC Institutional Enhancement Enclosure with this letter, which lists suggestions deserving the school’s immediate attention and action.

UEI College should direct its continued attention toward ensuring that the school can show in an ongoing manner acceptable pass rates on licensure/certification exams where required by governmental entities to work in a particular career field (*Section VII (B)(2)(b), Substantive Standards, Standards of Accreditation*). Based on information provided by the school, the Commission understands the State of Washington provides a one-year temporary certificate to allow new Medical Assistant graduates to work in the field. Regardless of the temporary certificate, UEI College is responsible to report and show acceptable licensure/certification exam pass rates based upon those students who take the exam annually.


