At the September 2024 meeting, the Accrediting Commission of Career Schools and Colleges (“ACCSC” or “the Commission”) considered the Application for a Branch Part II for the facility located at 885 Sunset Road SW, Albuquerque, New Mexico 87105 submitted by UEI College located in Gardena, California. This is to inform you that the information and records submitted satisfy the requirements set forth in *Section VIII (A)(1) & (B), Substantive Standards, Standards of Accreditation* for the establishment of a branch campus. United Education Institute located in Albuquerque, New Mexico is now classified as a branch campus of UEI College located in Gardena, California and included within the main school’s scope of accreditation as of the date of this letter. Please refer to the enclosed On-site Evaluation Enclosure regarding the on-site evaluation requirement for the review of this new facility.

As set forth in *Section VIII (B), Substantive Standards, Standards of Accreditation*, a main school is responsible for and accountable to the Commission for its branch campus. The management and supervision oversight of the branch must be carried out by the same ownership and management that controls the main school and is ultimately responsible and accountable for compliance with accrediting standards by its branch campus. As such, the continued accreditation of the main school requires adherence to accrediting standards by the branch campus. Moreover, the accredited status of the branch campus is dependent upon continued accreditation of the main school.

By becoming an accredited institution, United Education Institute located in Albuquerque, New Mexico accepts the obligation to demonstrate compliance with the Standards of Accreditation. While the Commission employs its own fact-finding methods to determine a school’s compliance with accrediting standards, the burden rests with the school to establish it is meeting the Standards of Accreditation.

An ACCSC Program Enclosure has been included with this letter as documentation of the school’s approved programs. Programs approved within the scope of the main school’s accreditation will be approved within the scope of the branch campus’s accreditation effective the date of this letter. In addition, the school submitted an Application for Initial Distance Education approval for the Automotive Technician (Diploma), Electrician Technician (Diploma), Heating, Ventilation and Air Conditioning (Diploma) Business Office Administration (Diploma), Dental Assistant (Diploma) Medical Assistant (Diploma), and Medical Billing and Insurance Coding (Diploma) programs. This approval includes the recognition of the hybrid delivery for the programs offered at the branch location. Only those programs operating at the branch campus at the time of the first renewal of accreditation on-site evaluation will have continued approval as part of the branch campus’s scope of accreditation (*Section IV (E)(5)(a) (viii)(1), Rules of Process and Procedure, Standards of Accreditation*).

A branch that is granted initial approval of accreditation will be required to undergo an on-site evaluation within six months of the start of the first class at the branch campus separate facility. Upon completion of the on-site evaluations, the team's findings will be presented to the school and the school shall have an opportunity to respond to those findings as necessary. The Commission will review the team's report and the school's response and will make a final determination relative to the continued accreditation of the branch.

The initial grant of accreditation to the branch is for a period of two years in duration going forward from November 4, 2024 of this letter (*Section IV (E)(5)(a)(vi), Rules of Process and Procedure, Standards of Accreditation*). In accordance with the procedures for Renewal of Accreditation the individual responsible for the branch's day-to-day operations is directed to attend an Accreditation Workshop in **2025** (details forthcoming). The school will be required to complete an Application for Renewal of Accreditation and a Self-Evaluation Report in accordance with the dates and timelines prescribed at the Accreditation Workshop.
